

# Trading Account(s) Migration Agreement

**Effective Date: 13 May 2019**

I am aware that Vantage Global Prime Pty Ltd, AFSL no. 428901 will no longer be offering its services to clients residing outside of Australia as of **13 May 2019**.

I agree to have my trading account(s) with Vantage Global Prime Pty Ltd, AFSL no. 428901 be migrated under Vantage International Group Limited – a company authorised and regulated by the Cayman Islands Monetary Authority ('CIMA') Licence no. 1383491.

I understand and agree that as results of this migration process, my personal information (including KYC information), account(s) balances, deposit and withdrawals records, open positions, trading history and any other information currently held by Vantage Global Prime Pty Ltd, AFSL no. 428901 will be transferred to Vantage International Group Limited.

I agree that any LPOA and, where relevant, associated Introducing Broker agreement, will be migrated to enable trading and rebates to continue on the basis that Vantage International Group Limited will now receive trading instructions.

I direct Vantage Global Prime Pty Ltd, AFSL no. 428901, to transfer all monies it currently holds on my behalf on statutory trust to a bank account held by Vantage International Group Limited.

I understand and agree that as of **13 May 2019** I will no longer be contracted with Vantage Global Prime Pty Ltd, AFSL no. 428901 and all my dealings including reconciling open positions, money transactions, instructions I conduct after this date will be contracted with Vantage International Group Limited.

I acknowledge and understand that by agreeing to have my account(s) migrated from Vantage Global Prime Pty Ltd – an ASIC regulated entity to Vantage International Group Limited – a Cayman Islands regulated entity, certain protections and safeguards under the ASIC regulation will no longer apply to my account(s). These include and not limited to:

- Client Money Protection under ASIC Client Money Reporting Rules 2017;
- Access to the Australian Financial Complaints Authority (AFCA) for any disputes handling;
- Total financial transparency, with the submission of periodic audit reports.

By agreeing below, I acknowledge that I am electronically signing the Vantage International Group Limited [Client Agreement](#) and related documents and that this is a legally binding contractual agreement. I confirm I understand the full nature and risks of trading in the Foreign Exchange, Contract for Difference and other derivatives.

I confirm that I have read, understood and accepted the current [Best Execution Policy](#), [Conflicts of Interest Policy](#), [Risk Warning Notice](#) and [Privacy Policy](#) set out by Vantage International Group Limited and by submitting this application, I agree to be bound by the terms of these documents.
